Cancellation, Payment, Pet and Privacy Policy are listed below.

# **Cancellation and Payment Policies**

### **Reservation and Payment Policy**

- Reservation Guarantee: A valid credit card is required to guarantee your reservation.
- **Deposit**: A deposit equal to the first night's stay is required at the time of booking.
- **Final Payment**: The remaining balance is due upon check-in. We accept all major credit cards, debit cards, and cash.

# **Cancellation Policy**

- **Standard Reservations**: Cancellations must be made at least 72 hours prior to the arrival date to avoid a cancellation fee.
- Holiday and Special Event Periods: Cancellations must be made at least 14 days prior to the arrival date to avoid a cancellation fee.
- Cancellation Fee: Cancellations within the cancellation window will result in a \$25 processing fee being deducted from the deposit.
- Late Cancellations:
  - Standard Reservations: Cancellations made within 72 hours of the arrival date will forfeit the deposit.
  - Holiday/Summer (Memorial Day to Labor Day) and Special Event Periods:
     Cancellations made within 14 days of the arrival date will forfeit the deposit.
- **No-Shows**: Guests who do not arrive on the scheduled arrival date will forfeit the deposit and the reservation will be canceled for the remainder of the stay.

#### **Resort Fee**

- Memorial Day to Labor Day: \$20.00 per night, per room.
- Labor Day to Memorial Day: \$10.00 per night, per room.
- This fee covers amenities such as:
  - Pool and beach area activities
  - Entertainment
  - Kayaks
  - Free WiFi
  - Free firewood
  - Discount Coupons

# **Pet Policy**

- **Pet Representation**: By bringing your pet, you represent that your pet is gentle, well domesticated, and has no violent propensities.
- **Supervision**: Pets must not be left unattended in your room. Dogs can become nervous and may bark, disturbing other guests.
- Pet Limits: A maximum of 2 dogs per unit is allowed. Cats are not permitted.
- Pet Fee: \$20 per day, per dog.
- Liability: You are responsible for any liability, claims, losses, costs, and expenses
  caused by your pet. You agree to indemnify Baker's Sunset Bay Resort from any such
  claims.
- **Objectionable Pets**: If your pet becomes a disturbance to other guests, you must remove the pet upon request or pay the cost to reimburse affected guests.
- Leash Policy: Pets must be kept on a leash or in a crate in public or common areas.
- Housekeeping: Housekeeping services are not provided for units with pets unless specially requested. Pets must be removed from the room during housekeeping or you must be present with the pet.

**Please note**: Dogs are not allowed in the lake or on the beach due to Lake Delton City Ordinance.

Upon arriving you will be asked to sign our pet policy agreement.
